Inland Empire Coordinated Care Initiative (CCI) Advisory Committee

I. PURPOSE OF COMMITTEE

The purpose of the Riverside and San Bernardino Counties CCI Advisory Committee, hereinafter referred to as "IE CCI Advisory Committee," is to provide a forum for structured input regarding how managed care health plans participating in the Dual Eligible Demonstration in both Riverside and San Bernardino Counties develop, implement, and operate seamless access and coordination across the full continuum of services – from medical care to long term services and supports (LTSS) for dual eligible beneficiaries in the Inland Empire in accordance with SB 1008 (2012) and SB 1036 (2012).

Managed care health plans participating in the Dual Eligible Demonstration will take the IE CCI Advisory Committee's input into consideration in their development, implementation, and operations of the CCI.

II. BACKGROUND

"Dually eligible individuals" or "dual eligibles" are seniors and individuals with disabilities enrolled in both the federal Medicare program and the state-run Medi-Cal program. Medi-Cal and Medicare are partnering to launch a three year demonstration promoting coordinated care delivery in Los Angeles, Orange, San Diego, San Mateo, Alameda, Riverside, San Bernardino, and Santa Clara Counties.

III. SCOPE OF COMMITTEE

The IE CCI Advisory Committee will advise participating health plans on developing, implementing, and operating the Dual Eligible Demonstration in Riverside and San Bernardino Counties. The Committee will further information sharing between entities that serve dual eligibles and provide input for policy positions that promote the interests of dual eligibles in the Inland Empire.

IV. ROLE AND RESPONSIBILITY OF COMMITTEE MEMBERS

The IE CCI Advisory Committee Committee will:

- 1. Provide stakeholder input and advice on programing, benefits, access to services, adequacy of grievance process, and consumer protections during the development, implementation, and operations of the demonstration in the Inland Empire.
- 2. Recommend the most appropriate mechanisms for outreach and education to both consumers and healthcare providers in the Inland Empire community about the demonstration including: eligibility and enrollment, program benefits, and consumer protections.

3. Provide feedback on proposals and legislation to the State of California and Centers for Medicare and Medicaid Services.

V. STRUCTURE

The IE CCI Advisory Committee will advise the participating health plans on all Coordinated Care Initiative related issues.

Participating health plans will take the IE CCI Advisory Committee's input into consideration in their development, implementation, and operations of the CCI.

The IE CCI Advisory Committee will elect a Committee member to serve as the Chair and a Committee member to serve as the Vice-Chair.

Membership of the IE CCI Advisory Committee should be based on both the unique and multi-dimensional needs of the Inland Empire dual eligible community, as well as the stakeholder recommendations and readiness requirements established by the California Department of Health Care Services (DHCS).

VI. PROCEDURES

The IE CCI Advisory Committee will elect a Chair to serve a term of one (1) year. A member of the Committee may nominate a fellow Committee member or him or herself for the position of Chair. All members of the Committee may vote in the election. The Committee may decide to rotate the Chair position between the various stakeholder groups and communities.

Committee meetings are open to the public for participation by all stakeholders. Stakeholders who are not voting members of the Committee may present during the designated public portion of each meeting. Public comments are limited to one (1) minute per speaker.

Meeting support will be provided by IEHP or Molina Healthcare of California staff.

Robert's Rules of Order will be followed by the committee and the public.

VII. TERM OF SERVICE

The term of service for an IE CCI Advisory Committee member is one (1) year

VIII. STIPEND FOR COMMITTEE MEMBERS

Members of the IE CCI Advisory Committee who are consumers occupying Committee seats designated for consumers shall be entitled to a maximum stipend of \$75 per meeting. Twenty-five of the seventy five dollars is intended to cover caregiver expenses. Should consumer attend telephonically, the total stipend shall be fifty dollars (\$50.00). Both Molina Healthcare and Inland Empire Health Plan shall alternate paying stipends to consumers. No other committee members are eligible for this stipend.

IX. FREQUENCY OF MEETINGS

The IE CCI Advisory Committee will meet on a bi-monthly basis. The Committee may convene for ad hoc meetings between the regularly scheduled meetings.
